CERTIFICATE OF AMENDMENT TO THE REPLAT DECLARATION FOR SECTION A OF WHISPER WALK

WHEREAS, the By-Laws of WHISPER WALK SECTION A ASSOCIATION, INC., are attached as an exhibit to said Replat Declaration; and,

WHEREAS, at a duly called and noticed meeting of the membership of WHISPER WALK SECTION A ASSOCIATION, INC., a Florida not-for-profit corporation, held on May 17, , 1989 the aforementioned Replat Declaration and By-Laws were amended pursuant to the provisions of said Replat Declaration and By-Laws.

NOW, THEREFORE, the undersigned hereby certify that the following amendment to the Replat Declaration and By-Laws is a true and correct copy of the amendment to the Replat Declaration and By-Laws, as amended by the membership:

PROPOSED AMENDMENT TO SECTION 5
OF THE BYLLAWS FOR
WHISPER WALK SECTION A ASSOCIATION, INC.

Section 5

Powers and Duties of the Board of Directors

Inasmuch as Whisper Walk Section A ts designed and intended a community for older persons, to provide housing residents who are fifty-five (55) years of age or older, Board of Directors shall have the power to require that no unit shall, at any time, be permanently occupied by children who are under fifteen (15) years of age; except that children below the age of fifteen (15) may be permitted to visit and temporarily reside for periods not exceeding sixty (60) days per calendar year. No permanent occupancy of any unit shall be permitted by an individual between the ages of fifteen (15) and fifty-five Notwithstanding same, the Board in its sole discretion shall have the right to establish hardship exceptions to permit individuals between the ages of fifteen (15) and fifty-five (55) to permanently reside in the community, providing that said not be permitted in situations where exceptions shall granting of a hardship exception would result in less than 80% of the units in the Condominium community having less than one resident fifty-five (55) years of age or older, it being the intent that at least 80% of the units shall at all times have at least one resident fifty-five (55) years of age or older. The Board of Directors shall establish policies and procedures for the purposes of assuring that the foregoing required percentages of adult occupancy are maintained at all times. The Board, or its designee, shall have the sole and absolute authority to deny occupancy of a unit by any person(s) who would thereby create a

violation of the aforestated percentages of adult occupancy. Permanent occupancy or residency shall be defined in the Rules and Regulations of the Association as may be promulgated by the Board. Notwithstanding the foregoing, occupancy of a unit on a permanent basis is limited to two (2) individuals for all 1-bedroom units, and four (4) individuals for all 2-bedroom units, however, individuals in excess of this number may be permitted to visit and temporarily reside in a unit in the Condominium for periods not to exceed sixty (60) days in toto in any calendar year with the written prior approval of the Association.
