4.4 The term of each Director's service shall be for a term of two (2) years. Beginning with the Annual Members' Meeting in March, 1988, four (4) Directors shall be elected for a term of two (2) years, expiring at the meeting set for December, 1989; three (3) Directors shall be elected for a term to expire at the Annual Members' Meeting in December, 1988, Beginning with the Annual Members' Meeting in December, 1988, and all Annual Members' Meetings subsequently, those positions of Directors whose terms have expired shall be elected for new terms of two (2) years, extend until the next Annual Members' Meeting and thereafter, until his successor is duly elected and qualified or until he is removed in the manner elsewhere provided herein.
